

16 DISSOLUTION

16.1 On dissolution or final liquidation, the Board of Directors shall, after paying or making provisions for the payment of all lawful debts and liabilities of the Corporation, distribute all the assets of the Corporation to one or more regularly organized and qualified charitable, educational, or scientific organizations to be selected by the Board of Directors, as more fully specified in the **Articles of Incorporation** of the Corporation.
